1475 Fort St apartment - Redevelopment of 3 story apartment block - developer bypassed rezoning and proposed variances to build a 50 foot high apartment with reduced setbacks. Now a modified rezoning approach is underway. Waiting for changes from the developer (modified plans.)

Infill lot on Pemberton: no updates.

1737 Rockland - the comment period closed last month. Next step: Developer to submit application to the city

St Charles Trillium Care centre - no updates.

2 - 3 more rezoning applications could be coming forward in the next few months.

Environment (Dave C)

Dave emailed a copy of the Rockland Garden strategic plan this week, which has been updated to include Janet's activities. Janet will be invoicing shortly for expenses.
